MINUTES OF MEETING OF KEMNAY COMMUNITY COUNCIL HELD ON THURSDAY 26TH MAY 1988 IN KEMNAY ACADEMY

- 1. The Chairman welcomed everyone present. The apologies were read.
- The Minutes of the previous meeting were read. Proposed adoption: D Evans, seconded: Mrs T Brown. Passed with no dissent.
- 3. Matters arising:-
- (a) Gordon Local Health Council Consultative Document. We had been notified at very short notice of a meeting that morning at Inverurie Hospital. Unfortunately we had been unable to send a representative. The closure of the Maternity Ward at the Hospital is an integral part of this document. A discussion ensued and it was decided not to take any action on this matter.
- (b) Swimming Pool Committee Formation. The Chairman outlined the background to this item for the benefit of Mr Bisset. Mr Bisset said he would be agreeable to standing on the Committee. It was felt generally that a pressure group rather than a fund-raising body might be a better idea in the first instance. Mr Armstrong told the meeting that he was a founder member of Cults Swimming Club and is an ASA Tutor. Be felt the feasability should be studied in the first instance. Possible members of the Committee might include an architect, the local banker, the rector of the Academy and representatives of the feeder schools, representatives from Garioch Swimming Club, Kemnay Community Council, the Scouts, Guides, Girls and Boys' Brigades, Community Education, the Regional Councillor and local Sports Council Representative. Cllr Wainman suggested that the formation of the Committee be left to Mr Armstrong and Mrs Crighton as interested parties. Mr L Brown agreed to be the Community Council representative. Mr Wainman suggested £25 from funds to get the Committee going. Proposed £25 financial support on satisfactory secretarial help being found Mr Evans. Seconded Mrs Brown. Passed by a majority. The Chairman proposed that Mr Armstrong be co-opted on to the Community Council for the time being and that he have the power to co-opt whoever he wants as committee members. The committee to be a sub-committee of the Community Council for the time being. Mrs Brown seconded the motion. Passed by a majority.
- (c) Keep Kemnay Clean Day. Mr Yates reported that the turnout was a little disappointing as only six people turned up. Between them they collected 20 full sacks between the Academy and the Burnett Arms. The majority of rubbish was crisp packets a large part of which came from directly below the Academy. Discussion ensued on the litter problem. Mr Evans to contact the Scottish Consumer Unit on behalf of the Community Council.

- (d) Anti-Litter Poster Competition. Mr Evans suggested short videos rather than posters as he felt most schools had the equipment for this. Mr Bisset said he would be happy to encourage pupils at the Academy in this regard. He also suggested the possibility of a video of litter in Kemnay and this could be shown in the Village Ball together with a poster and photograph competition. It could also be shown in the schools. It would be necessary to ask permission of the other two Headmasters in the showing of the finished video. Letters to be written to the Headmasters.
- 4. The two Police Officers introduced themselves. Sqt Donald is now in place of Sgt Downie at Inverurie. Mr Yates asked about the level of late-night policing in the area. The meeting was told that two Police Officers are now in Kemnay. One might be late shift and the other day shift. There was now 24-hour coverage in the Gordon Division. Mention was made of the answerphone. The meeting was told hat the police use the answerphone to put in reports. Mr Wainman entioned that a lot of children cycle the wrong way up the High Street. The Chairman mentioned the litter problem and asked if the Police might mention it on their school visits. Mr Yates asked whether any measures were being taken against speeding offenders. He, was told they were. The Chairman thanked the Police for their attendance.
