

MINUTES OF MEETING OF KEMNAY COMMUNITY COUNCIL HELD ON THURSDAY 27TH
APRIL 1989

1. The Chairman welcomed everyone and the apologies were read.
2. The Minutes of the previous meeting were read. In No 11 the words "Planning Applications" were inserted. Proposed adoption: Mr Wainman, seconded: Mr Cumming. Passed no dissent.
3. Matters arising:-
 - (a) Clean-Up Day. Rendezvous at the Car Park in Aquithie Road at 9.30 a.m.
 - (b) By-Election. Mr Wainman suggested an election should take place. The Chairman suggested this be left in abeyance until the Autumn. Mention to be made in the Newsletter of the two vacancies. AGENDA ITEM September meeting.
4. Unfinished Business. Ecolinc - Mrs Evans had received the Minutes of the meeting she attended. Mr Wainman suggested copies of the Newsletter be sent to Ecolinc. The Secretary to attend to this.
5. Correspondence received.
6. New Business. Mrs Brown asked whether there were any matters to be raised with the Medical Liaison Committee. Mr Evans mentioned the proposal to charge for the car park at Foresterhill and it was agreed to write to the Health Board about this.
7. District News. Cllr Wainman said that Mr Keir's application for the taxi business had been turned down again. He is applying to the Secretary of State. There is to be a new dog sign erected in place of the vandalised one. A Dog Warden is to be employed by Gordon District and also a Pest Control Officer.
8. Regional News. Yellow lines in High Street - this has gone into committee. Aquithie Road re-surfacing - Cllr McLean said this to be left in abeyance until it is known whether Gas is coming to the village. Letter to Gas Board re our letter of the 30th March to which we have not received a reply. Donview Road/Kendal Road markings - these would appear to be all right however the Council to look into lifting some rose-beds to provide more parking.
9. Planning Applications. Four in all. Nothing contentious. Mr Evans also mentioned two applications for clearance and replanting of forest land at the Horner and Craigmyle.
10. A.O.C.B. The Police were asked whether the youth mentioned on their previous visit had yet been sentenced. They have not heard. The Police were asked to check litter droppers and also to dissuade skateboarders from using the roads. Cllr Wainman mentioned

that she had received complaints from residents that children were playing football in the street in Millstone Place, which has a high number of elderly residents. Constable Carmichael mentioned that there had been some under-age drinking in the public toilets, and asked whether they could be locked. Cllr Wainman said that it would not be viable to do so as someone would have to be employed to do this. She is to check whether there is a bye-law to prevent drinking in toilets. The Chairman proposed a letter to the Council re the problem and this was unanimously agreed.

11. Next meeting - Thursday 25th May 1989. There being no further business to discuss the meeting ended at 8.40 p.m.

PARKING RESTRICTIONS AT HIGH STREET, KEMNAY

I have received a complaint from Kemnay Community Council via Councillor McLean regarding cars parked at the side of the Spar General Store in High Street, Kemnay. *trace*

The problem is that cars park in the area between the yellow lines and the building forcing pedestrians on to the roadway. The area is owned by the Storekeeper, Mr. C. Robertson, who is willing to allow a 1.50 metre footpath to be constructed provided that there is no loss of parking space.

It is therefore proposed to remove the "No Waiting at Any Time" restriction between the shop front and access and to extend the "45 min. (No Return in 15 min.)" restriction over this area.

I would be obliged if you would consider the above proposals and I look forward to hearing from you before 31st May, 1989.

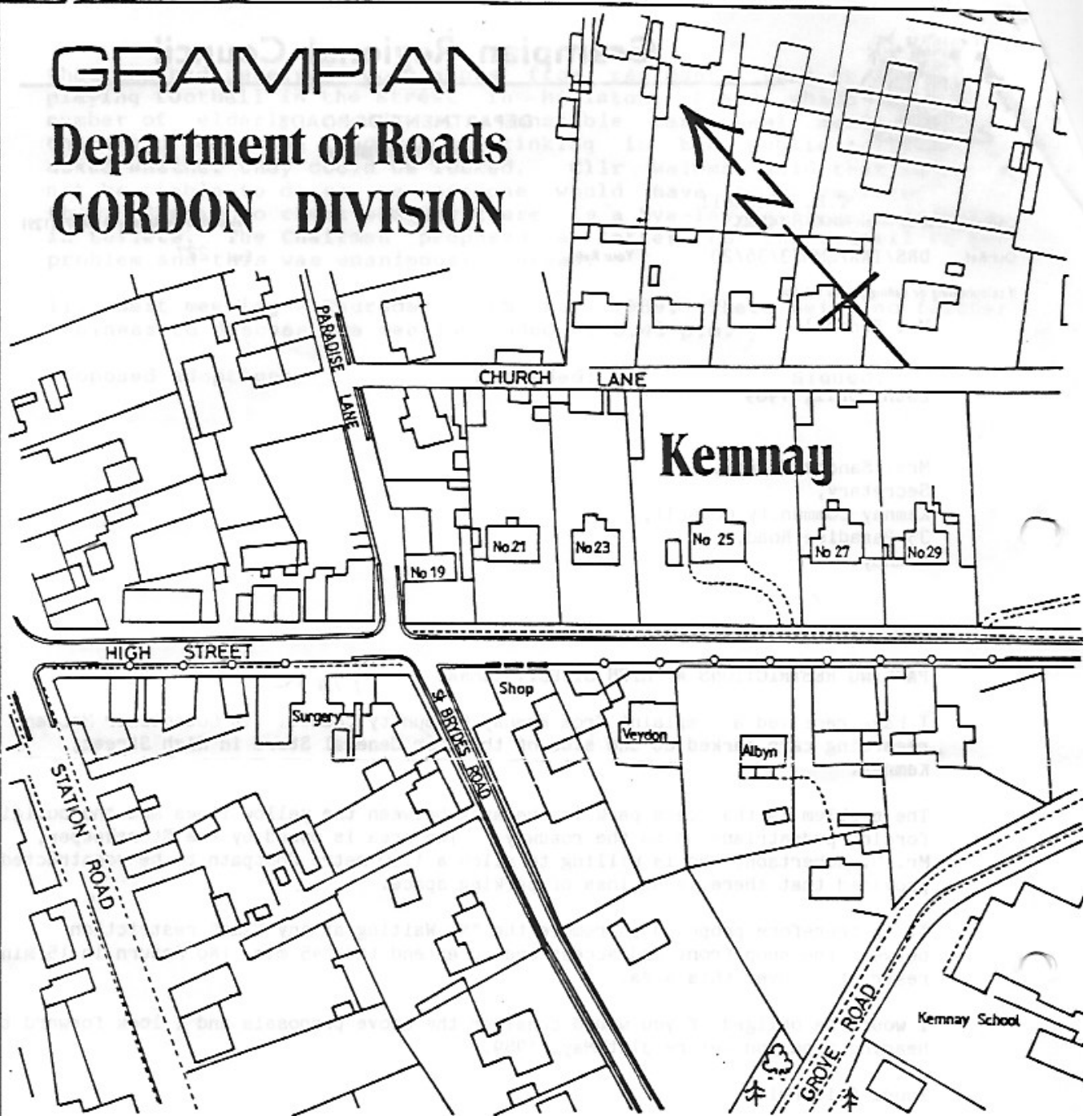
