Minutes of meeting held on 28th February 1978 in Kemnay School.

The Chairman offered the Councils congratulations to the Innes family on their new arrival. He welcomed the large number of public at this meeting.

The minutes of the previous meeting were accepted on the motion of P.Shanks and J.Horn.

Mr. Hughes moved that the agenda be altered to accommodate the interest of the public present therefore

Business arising:

Craigmyle Explosive magazine. The Secretary gave details of the meeting with M.P. and the Chairman on the meeting with Schlumberger Inland Services Inc., and a letter from Gordon District Council was read. The public were then allowed to take part in the discussion. Mr. Harley presented a letter sent by Mr. Paul Miller to Gordon District Council. It was agreed that a letter of objection would be sent to Campian Regional Council and also to state the additional conditions that we require as a safeguard to the granting of the license. Please see attached copy letter. It was agreed to contact both the Forestry Commission and the Hydro-Board to try to enlist their support also the Baillies of Bennachie. It was agreed to write to Gordon District Council stating that we wish them to object to the granting of the license and that we wish them to ~~revoke the original planning~~ permission for the magazine.

Aberdeen structure plan. It was agreed to postpone decisions until the next meeting

Noticeboard. No further information available.

Membership and constitution. It was hoped to deal with this at April meeting.

The Chairman requested that a questionnaire should be prepared to try to give the Council a truer view of the public. It was agreed to set up a sub committee of P.Shanks, M.Wainman, M.Morris to report back for 21st March.

The Secretary reported that the report on Aggregates extraction was now available and it was agreed that one copy of each should be purchased.

The residents of the Glebe, Kemnay had approached us about the region taking over this road, on enquiry it was found that there had been a breach of planning and until such time as this was rectified, the road would not be taken over. It was agreed to write to Gordon District Council as planning authority to find out why it had been allowed to happen and what was being done about it.

Date of the next meeting was set for 21st March 1978.
