Business arising from the minutes .:

- Mr McKay reported that a number of minor repairs and improvements to the play equipment in the Pleasure Park had been carried out. The Kemnay Park Pavilion Committee had met and had decided to commence fund raising through a 100 club.
- 2. Temporary erection of Play equipment at Alehousewells
 Mr McLean reported by letter that he had been informed that the
 equipment was almost ready for erection.
- Remnay Oldschoolhouse Mr McLean reported by letter on discussion etween himself and Grampian Region Education Dept officials on possible use of the house and conditions likely to be applied.

 J. Hern suggested that the secretary invite all interested parties to attend next Community Council Meeting to provide definite ideas on what use they could make of the property. This was agreed. It was further agreed that if it could be shown that the Schoolhouse could and would be used then a meeting would be arranged with Grampian Region Education Dept officials to discuss details.

- b. The Chairman reported that Mr B. Innes had prepared an article with photographs on the work of the Council for inclusion in the Community Council News magazine. Mr Innes was thanked for his work.
- c. At the invitation of Mr Dick, Grampian Region Education Dept a list of suggested names for the new academy to be built at Kemnay was submitted.
- d. The poor state of the pavement on Victoria Terr. adjectent to its junction with Parkhill was cau ing concern to residents. It was decided to ask Mr Mitchell of the G.R. roads Dept to deal with the matter.
