1 Mr Alan Davies took the chair and welcomed the members. It was decided to postpone the election of office bearers until the May meeting.

2 The minute of the meeting held on 30th March 2000 was agreed to be true with the substitution of item 5 which was tabled.

3 Matters arising from the minute

Councillor Leitch reported that a new consignment of 'doggie bins' had arrived and hoped some had been placed by the river at Fetternear View
The evening bus service from Inverurie had been resumed without any unseemly incidents being reported.

4 A letter from David Evans was read concerning the proposed siting of a mobile 'phone mast at Kemnay quarry. A site visit was arranged for Tuesday May at the Fyfe Park car park at 7.0pm to view the proposed position.

5 Mr Davies then introduced Mr & Mrs Whittall who gave a resume of the history of Fetternear House and the proposals for conserving and/or restoration of the ruins, restoring part to form a single large house for letting and an interpretation centre showing that history. A trust was being set up to raise funds. There was discussion on the proposals with questions on public access and safety. The members wished the project success and thanked Mr & Mrs Whittall for their presentation.

At the request of the Minister there was to be a two hour cross party meeting. The new Garioch Area Manager would be Ian Fowell and it was decided to invite him to one of our meetings.
